### **Definition of special educational needs**

In this plan, 'special educational needs' refers to a learning difficulty that requires special educational provision.

The SEND Code of Practice 0 to 25 Years (DfE, Jan 2015) says children have a learning difficulty or disability if they:

- have significantly greater difficulty in learning than the majority of children of the same age; or
- have a disability which prevents or hinders them from making use of facilities of a kind generally provided for children of the same age in mainstream schools or post-16 institutions; and
- are under compulsory school age and are likely to fall within either of the definitions above when they reach compulsory school age or would do so if special educational provision was not made for them.

Children must not be regarded as having a learning difficulty solely because the language or form of language of their home is different from the language in which they will be taught.

### **Definition of disability**

Disability is a term defined under the Equality Act 2010 as a physical or mental impairment which has a substantial adverse long-term effect on the individual's ability to carry out normal day to day activities.

### **Definition of special educational provision**

For children aged two years or older, this is educational provision additional to, or otherwise different from, the educational provision normally available to students of the same age in mainstream provision in England.

The Cowplain School has adopted this Accessibility Plan in line with the school's Special Educational Needs Policy with the aim of ensuring that our school is socially and academically inclusive, that all students have access to a full curriculum, and that all students are appropriately challenged.

This accessibility plan forms part of the school's approach to meeting the needs of all our pupils. The plan should be read in conjunction with the school's **SEND policy and SEND information report** and shall be published on the website.

Our Special Educational Needs Policy outlines the school's provision for supporting students with special educational needs and disabilities (SEND), and the school's publication of equality information and

objectives explains how we aim to ensure equal opportunities for all our students through increased access to the curriculum, improving the physical environment at the school and enhancing availability of access to information, with a particular focus on students with SEND. This Accessibility Plan provides an outline of how the school will manage this part of the SEND provision.

**School estate – major capital expense**

The School site is spread over a large area and includes 7 older buildings built between 1930 to early 1970s. The site can be difficult to move around and access for people with physical disabilities are limited. We endeavour to accommodate access with portable ramps but other than a set classroom, this is very limited. During refurbishments the school has considered disabled WCs and there are now two available in different buildings. There is one allocated disabled car parking space.

The school will take account the needs of students and other users with physical difficulties and sensory impairments when planning and undertaking future improvements.

Where there had previously been no available handrail these have now been installed to support steps into 2 buildings with step access.
